1. Call to Order – This Sustainability Committee Meeting has been called in an abundance of caution to satisfy the Ralph M. Brown Act. The committee is an Ad Hoc committee of the CeSPNC and is advisory in nature to the Board. Any decisions made at this committee are not considered Board actions, unless it is given the power to act on an item, and shall go back as recommendations to the CeSPNC Board for a final vote at a regular or special Board meeting.
2. Discussion of a public comment letter concerning the Port of Los Angeles and Port of Long Beach's Clean Air Action Plan. **Possible recommendation and action.**
3. Discussion of a joint meeting with the Northwest San Pedro Neighborhood Council's sustainability committee in which there is a presentation on “Using Native Plants as a Response to California's Drought.”
 - a. Discussion of how to draw stakeholders for presentation.
 - b. **Possible recommendation and action** to Board and/or Finance Committee to approve of funding for snacks at the presentation for the Stakeholders.

Discussion of using reusable water bottles instead of buying plastic bottles for meetings; this includes discussion on how the Northwest SP Neighborhood Council has already implemented reusable water bottles. **Possible recommendation and action** to the Board for vote to implement a similar strategy.
